**Excerpt from the provisions of the EU Organic Regulation on the "ban on genetic engineering"
Regulation (EG) No. 2018/848 as amended**

Article 3: Definitions

- t) The definition of "genetically modified organism (GMO)" is the definition of Directive 2001/18 / EC of the European Parliament and of the Council of March 12, 2001 on the deliberate release of genetically modified organisms into the environment and on the repeal Directive 90/220 / EEC of the Council and which did not result from one of the genetic modification processes listed in Annex IB of Directive 2001/18 / EC;
- u) "Made from GMOs": obtained wholly or partially from GMOs, but not consisting of or containing GMOs;
- v) Manufactured by GMOs: obtained using a GMO as the last living organism in the production process, but not consisting of GMOs, containing GMOs or made from GMOs;

Article 11: Prohibition on the use of GMOs

- (1) GMOs and products made from or through GMOs may not be used as food, feed, processing aids, pesticides, fertilizers, soil improvers, seeds, vegetative propagation material, microorganisms or animals in organic production.
- (2) For the purposes of the prohibition in accordance with paragraph 1 relating to GMOs or products made from GMOs in connection with food and feed, entrepreneurs can rely on the label on the product or on the accompanying documents, which in accordance with Directive 2001/18 / EC, Regulation (EC) No. 1829/2003 of the European Parliament and of the Council of 22 September 2003 on genetically modified food and feed or Regulation (EC) No. 1830/2003 on the traceability and labelling of genetically modified organisms and on the traceability of food and feed produced from genetically modified organisms are attached to it or are provided with it. The entrepreneurs can assume that no GMOs or products made from GMOs have been used in the production of purchased food and feed if these are not labelled in accordance with the above-mentioned ordinances or provided with an accompanying document, unless the entrepreneurs have information which indicate that the labelling of the products in question does not comply with the aforementioned regulations.
- (3) For the purposes of the prohibition in accordance with paragraph 1 with regard to products other than food and feed or products manufactured using GMOs, entrepreneurs must request confirmation from the seller that the products supplied were not made from or by using GMOs, if they obtained and used non-organic products from third parties.
