Data subject rights	<p>We would like to point out that according to the Data Protection Ordinance, every data subject has the following rights:</p> <ul style="list-style-type: none"> <li>• There is a right to information, correction, erasure, restriction of processing or a right of objection to processing and a right of data portability.</li> <li>• There is a right to withdraw consent within the terms of Art. 6 (1a) or Art. 9 (2a) at any time without affecting legality of the processing that took place on the basis of the consent until withdrawal.</li> <li>• There is a right to complain to a supervisory authority.</li> </ul>
